Please, find the attached inscription folder for the « ancient tools and folk art objects Fair » that will take place on the 1st of May 2024, in Bièvres.

For 2024, important information to communicate :

- Except for displaying and repacking, NO vehicle is allowed to remain on the Tool Fair space for security reasons. All vehicles must be parked on the space dedicated to exhibitors.
- Please note that the Fair timetable has been modified. It is now from 8 :00 AM to 5 :00 PM.
- Due to the security situation, we will keep the occupancy level set in 2023 and blocking dams will be placed at several entry points.
- At the end of the day, the volunteers of LADO will be delighted to welcome you to share a friendly time .
- Finally, as it is always impossible for us to influence weather conditions, consider providing the necessary equipment to protect you and your goods from rain and cold.

This year, the emphasis is on the restoration of Notre-Dame de Paris and on the traditionnal tools and trades associated with it. This gives you the opportunity to show all your tool treasures...

**Ancient tools and folk art objects Fair's rules.
(Courtesy translation)**

Art.1 - Old tools and folk art objects Fair is organized by Les Amis De l'Outil (LADO) association.

Art.2 - The presence of old tools is mandatory on the stalls. The rest of the goods will be composed exclusively of folk art objects.

Art.3 - The selling price must be indicated on all objects for sale.

Art.4 - Sellers must respect the french law, particularly regarding the sale of weapons, Nazi propaganda objects, fakes, copies, or any other unlawful purposes.

Art.5 - Vehicles and their contents, exhibition equipment (stalls, tables, etc.) and objects for sale remain the responsibility of their owner : It's up to him to ensure his possessions against all the risks incurred (burglary, theft, breakage, fire, etc.).

Art.6 - Professional exhibitors must be able to justify this condition on simple request of the organizer, customers or any legal authority.

Art.7 - The organizer reserves the right to exclude any exhibitor who disturbs the good order or morality of the event, or contravenes the terms of this regulation.

Art.8 - The rents are issued by incompressible 2.00 m linear meters modules : therefore, the minimum booking will be 2.00 m long ; for longer lengths, provide a multiple of this distance. In contrast, the depth is from 1.5 to 4.0 meters.

Art.9 - Subject to the acceptance and the respect of the terms of this regulation, and according to the available places, will be taken into account only the files of registration considered as complete :

1. Presence of the registration form corresponding to the category of the seller (professional or non-professional-member) duly completed of all required informations *.
2. Compulsory presence of the booking check, the amount must match the length requested.
3. If the applicant must pay the amount of his contribution or his booking at the evening meal, join as many checks as needed, please. The collection will take place after the 1st of May.

Art.10 - The organizer reserves the right to invite exhibitors or demonstrators, according to his own criteria and in accordance with the french Code pénal R-321.9 Art.

Art.11 - After installation of the stands, and before the official start of the event (08:00 AM), vehicles have to be moved and parked in the parking lot reserved for exhibitors. Exhibitors can only get them back at 05:00 PM.

In all cases, these trips must be done in accordance with the traffic rules set up that day.

Art.12 - Early departures (before 05:00 PM) are not allowed, except on the express authorization of the organizer.

Art.13 - The rented location must be returned clean of any waste. Garbage bags will be distributed for this purpose, and containers will be arranged in several easily accessible places.

Art.14 - Except in exceptional cases, cancellation requests have to be made before midnight **on Saturday, 20h of April 2024**. Only telephone messages and emails will be taken into account (because they can be dated).

* As a legal obligation, LADO provides the authorities with a copy of the list of exhibitors.
